

CONTRACT

All EXHIBITORS acknowledge that the regulations contained herein as well as in Exhibition Regulations are integral and agree to be bound by them. The organizer, JPCA is entitled to interpret and enforce all regulations in the best interests of the Shows.

Exhibit Category

The Show site will be structured by the exhibited content classifications to lead where all attendees wish to approach and promote effective exhibition. Please confirm "Exhibition Guide".

WECC Membership

In this Show, WECC Member companies will have the priority to exhibit with JPCA Membership discount.

Deadline for Application

Please make sure that the APPLICATION FORM will reach the Taiwan Printed Circuits Association (TPCA) by the final deadline, Friday, February 13, 2015. Booth allocations will in principle be determined by the exhibitors' selection in early order of applications, among those exhibitors applying for the same types and number of booths at same exhibition (area, zone) category. Please see P.6 of "Exhibition Guide" for more details.

To become Exhibitors

JPCA will issue and send invoice to Applicants who is accepted as Exhibitors instead of issuing Acceptance Notification. If your exhibits are unfitted to the show objectives, your exhibition application may be either deferred or rejected.

Payment

JPCA will issue the invoice to Applicants. Payment shall be made in Japanese Yen and must be remitted to the JPCA's bank account by March 13, 2015 with all transfer charges paid by the sender. Promissory notes cannot be accepted as payment. Failing to pay in time shall be considered to have cancelled to exhibit and a specified cancellation charge will be imposed.

Cancellation

If exhibition will be cancelled, for whatever reason, in whole or in part, the following cancellation charges must be paid. Please note that the Consumption Tax will be added to the cancellation charges.

Notification of cancellations required in writing, either delivered by mail or transmitted by facsimile, and shall be effective on the date of receipt by the JPCA.

Extra Service Payment

Each contractor will issue invoices for charges of packaged-booth, internet, telephone installation (use of internet, telephone), electricity, air, and water supply, etc., during the show period. Please pay the charges in accordance with method of payment promptly.

Contract

This CONTRACT will become effective upon receiving the application form.

Constraints regarding the booths' lease, resale, transfer and exchange

It is prohibited for exhibition space, whether in whole or in part, to be sub-let, sold, transferred, or exchanged, regardless of whether the transaction is with another exhibitor or a third party.

Notice to Overseas Exhibitors/Overseas Products Exhibitors

(1) Restrictions with customs-cleared goods

The JPCA Secretariat will not submit applications needed to function as the bonded goods exhibition site. Therefore, as a rule, display items will be restricted to be domestic goods. All the necessary procedures and arrangements for displaying foreign manufactured goods which have not cleared customs should be executed by the exhibitor.

(2) Visa-related documents cannot be issued

The JPCA Secretariat do not assume any responsibility for issuing documents for the purpose of procuring a visa which the exhibitor may be required in order to obtain entry into Japan.

Management of Exhibits

The organizer, JPCA, will do the best of its ability, provide for the security of exhibits during the Show period by means of security guard patrols. However, since the JPCA cannot assume responsibility for fire, theft, loss of property or other occurrences beyond its control, exhibitors should take good care of their property and take any precautions necessary, such as taking out insurance.

Prohibition at Exhibition Site

The actions listed below are forbidden by the Exhibition Secretariat. In the event that these rules are not observed, the 2015 Show Steering Committee will take appropriate corrective measures.

- 1) Carrying in dangerous materials and use of open fire in the halls.
- 2) All exhibits and related items, such as publications, fixtures, decorations, potted plants and the like, packing materials, etc. must be kept within the exhibitor's booth space, and not be left or placed outside the booth or in the corridors.
- 3) Smoking is prohibited. (except in the area designated by the organizer)
- 4) Taking photos and videotape recording of other booths on the show site are prohibited except for the news media that are given permission by exhibitors. Please remind you that the organizer (JPCA) will take photos in order to record this show and to attract visitors and exhibitors.

Cancellation by Irresistible Forces

If the 2015 Show cannot be held due to a natural disaster such as an earthquake, fire, or another force beyond control, the exhibitor's booth lease fees will be refunded, deducting a compensating charge for costs and expenses already incurred. JPCA assumes no responsibility for costs and expenses incurred by exhibitors.
